

Expression of interest from C&AG empanelled Chartered Accountant partnership firm for Statutory Audit of accounts of Zilla Parishad, Sundargarh for the FY 2022-23 to 2024-25. The Terms and Condition of the assignment are as follows.

ZILLA PARISHAD, Sundargarh invites offers in **TWO PARTS** (Technical and Financial) from interested Chartered Accountant Firms meeting all the criteria as mentioned in attached **Annexures and Forms** .The Chartered Accountant Firms should submit their offer in the **prescribed format (Annexure/Forms)** of this tender.

A. Scope of Works:

1. 100% verification of vouchers, Head of Account wise entries as Receipts & Payments in Cash Book / other financial statements.
2. Ensure arithmetical accuracy of all entries and all transactions recorded in Subsidiary Cash Books, Stock Register and reflected in Main Cash book.
3. Prepare monthly analysis of Opening & Closing Balance taking unadjusted advances given to different categories of employees including PRI representatives and fund position in different banks and post office.
4. Bank Reconciliation/Compilation of all Bank Accounts and Ledgers like Stock & Store, GIA Register, Demand Collection Register etc as prescribed under OGP Act.
5. Ensure all financial transactions are recorded in Cash Book and reflected in Pass Book as well and any deviation found is to be reported to the authority immediately.
6. Ensure correctness of accounts and suggest necessary actions points ,if any for rectification of the same.
7. The C A Firm / Members of the firm shall visit at least two times in a month to the District/Block/GP during the period of Audit.
8. The Firm is required to Prepare the Trial Balance and Annual Financial Statements i.e Receipt & Payment A/c, Income& Expenditure A/c and Balance Sheet Scheme-wise and Consolidated complying the previous pending paras.
9. After completion of the assigned work, the CA Firm shall mandatorily give their overall findings / views / suggestions / comments etc. for proper maintenance of accounts adopting latest available procedures.
10. Firm should ensure Audit of any left out schemes of ZP, Sundargarh for the previous financial years within the quoted price limit.

B. Time period of engagement:

The selected Chartered Accountant Firm will act as Statutory Auditor for one Accounting Year i.e.2022-23 which may be renewed for another two years on satisfactory completion of the assigned work. But the same CA Firm shall not be engaged for consecutive second term i.e beyond three years. The Agency, however ,reserves the right to discontinue the services of the Chartered Accountant Firm at any time during the period by serving one week notice

C. Time schedule:

The selected firm should submit the audit report of all scheme for the Financial Year 2022-23 within 30 working days from the date of agreement.

D. Reporting :

The Firm will submit the Audit Report of 2022-23 (Four sets) to the CDO-cum-EO ,Zilla Parishad ,Sundargarh.

E. General :

The firm will be given access to required information relevant for the purpose of conducting the audit. This would normally include Books of Accounts, all documents, correspondence, and other information associated with Zilla Parishad, Sundargarh during 2022-23. In addition to the audit report and the annual financial statement the firm should submit audit observation.

F. Qualification Criteria Of The CA Firm

A) The bids of only those firms will be considered, which satisfy the following eligibility criteria: The Chartered Accountant Firm should:

- Have registered with The Institute of Chartered Accountants of India (ICAI) and have Income Tax Permanent Account Number (PAN) and Service Tax Registration of firm (GST).
- Odisha based CA Firm and must have been empanelled as per latest order of Comptroller and Auditor General of India (C&AG) for 2023-24 or 2022-23.
- Have minimum 10 years of experience after its ICAI registration.
- At least have minimum 05 years of external audit experience in similar kind of Govt. Department/Organizations/Institutions or PSU Institutions /Training Institute/Societies under Panchayati Raj Department or any other Govt. Departments.
- Last three years average annual turnover should not be less than 10.00lakhs.
- Have at least two Partners. Concerned firm should submit the Partnership deed to this effect
- Have minimum three nos. of other Audit staff in addition to the Partners.
- Have not been blacklisted by any govt. or any other organization (PSU Institutions). Authorized Signatory(s) of the firm to **submit an undertaking** to this effect.
- **An undertaking** to the effect that no person of the firm / partner is related to any employee of the Zilla Parishad (ZP) nor have any interest in their activities.
- Submit relevant documents duly attested by the authorized signatory in support of the eligibility criteria given above.
- The Bidder will submit the relevant documents along with EMD of Rs. 5,000/- (Rupees Five Thousand) only in shape of **Demand Draft in favour of CDO-cum-EO, Zilla Parishad, Sundargarh , payable at Sundargarh** which will be refunded to unsuccessful bidder . The successful Bidder will get back his EMD after submitting Performance Security deposit of Rs. 5,000/- (Rupees Five Thousand) only in shape of **Demand Draft in favour of CDO-cum-EO, Zilla Parishad, Sundargarh ,payable at Sundargarh** which will be refunded after successful completion of Audit.

- The Bidder should submit the Tender cost fee of Rs. 500/- (Rupees Five Hundred) only in shape of **Demand Draft in favour of CDO-cum-EO, Zilla Parishad, Sundargarh ,payable at Sundargarh** which is non refundable.
- Firm must submit last 3 years (2019-20,2020-21,2021-22) Balance sheet, income/expenditure & profit/loss statement as a mandatory documents of the technical bid.
- Firm must submit last 3 years (2019-20,2020-21,2021-22) IT return as a mandatory documents of the technical bid.

B) The audit team for conduct of audit at Zilla Parishad must comprise of one Audit Manager and three Audit staff.

- The audit manager must be a qualified CA having at least 3years of post qualification experience.
- The Audit staffs must have 3years of audit experience in similar nature of work.

G. Payment Terms :

The payment against the services provided by the firm is subject to the following terms and conditions:

- The maximum audit fee per annum to be quoted is Rs.50,000/-(Fifty Thousand) only per including all applicable taxes . Firm quoting less than Rs.15,000/- (Fifteen Thousand) only including all taxes will be rejected and the quoted rate should be inclusive of all expense and taxes.
- The price quoted by the firm, should be valid for the entire contract period. Payment shall be made at agreed rates. No price variation would be allowed during the contract period.
- Service tax will be paid at prescribed rate.
- TDS will be deducted as per Income Tax Act/Rule.
- If the Firm will not provide satisfactory performance to Zilla Parishad ,Sundargarh and will not comply the objection/words of ZP within its stipulated time period then the Performance Security Deposit will not be refunded and also their financial Claims and participation in similar work in future will be restricted under breach of contract.

H. Submission Of EoI

i) **ANNEXURE-A** duly filled Qualification-cum-Technical Bid along with all supporting documents duly signed with Seal of the authorized Partner of the Firm should be submitted in one sealed envelope super scribed as-"TECHNICAL BID".

ii) **ANNEXURE- B** duly filled Financial Bid should be submitted in a separate sealed cover super scribed as "FINANCIAL BID".

iii)The above two envelopes containing Annexure-A/Forms and Annexure-B should be placed in One Covering Envelope and sealed super scribed as "EXPRESSION OF INTEREST FOR HIRING OF CHARTERED ACCOUNTANT FIRM".

iv) The technical bid should not contain any indication of price offered; else the entire bid will be rejected.

v) The Tender Paper should reach to the Office of CDO-cum-EO, Zilla Parishad, Sundargarh, Odisha latest by **12.00 P.M** on dt.**29.08.2023** through Registered post/Speed post/Physically **in the address of Chief Development Officer-cum-Executive Officer, Zilla Parishad ,Sundargarh- 770001**. Tender paper received after the due date and time shall be summarily be rejected.

vi) Date & time of opening of bid is dt:**29.08.2023, at 4.30 P.M** . The interested bidders or their authorized representatives are requested to remain present at the time of opening of bid.

vii) The authority reserves the right to accept or reject any or all the offers received or cancel the bidding process at any stage prior to award of contract and without assigning any reason thereof.

viii) Any dispute that may arise will be settled at any court under the jurisdiction of Sundargarh District.

I. Evaluation Of Technical Bids

(I) The Technical Bid received by ZP, Sundargarh and those meeting the above criteria, would be taken up for detailed evaluation as per the technical evaluation criteria, described in Annexure and Forms attached. The Bidder will be evaluated and assigned marks against the maximum score of 100marks.The selection will be made basing on highest marks secured by the Firm.

(II) After the selection in Technical Bid as per attached Annexure and Forms, the Financial Bid will be opened in the presence of the representative of the firm.

(III) The CA Firm Scoring highest marks will be considered for selection as the Statutory Auditor of ZP, Sundargarh for the financial year 2022-23.

(IV) Bidders are requested to submit all the necessary information in the prescribed Annexures and Forms attached below.

(V) The minimum qualifying marks for the bidder in technical bids is 25 marks out of 50 (i.e 50%)

(3.3) Zilla Parishad, Sundargarh reserve the right of negotiation with eligible Bidder before Finalization of the Bid Contract and to accept or reject any or all Bid in total or in parts or to split the work among more than one bidder without assigning any reason thereof.
