

Official Liquidator attached to the Hon'ble High Court of Delhi, invite Bio data/Application from the eligible Chartered Accountants or firms of Chartered Accountants, who are enrolled as Members of the Institute of Chartered Accountants of India and are in active practice for the last 05 years and are interested to be empaneled for the Official Liquidator as Auditors in the Companies under liquidation for assignment of Investigation of affairs of Company (in Liqn.), settlement of claim of creditors, workers etc. The applicants/firms who are interested may submit their applications inter alia furnishing (i) the details of income during the last 5 years along with Income Tax Returns (ii) Recommendations of two practicing Chartered Accountants having at least 10 years practice (iii) Certificate from Institute of Chartered Accountants that no disciplinary proceedings are pending against any of the proprietors/partners of the firm or the applicant Chartered Accountant.

The professional fee/remuneration for the settlement of claims of creditors, workers etc. shall be paid as per following fee structure :

Particulars	Fee Structure
For secured creditors	Rs.6000/- per secured creditor.
For (Govt. Statutory) claim	Rs.5000/- per claim.
For unsecured creditors	Rs.600/- per unsecured creditor.
For workers (where workers are less than 100)	Rs.700/- per worker.
Where workers are more than 100 and less than 1000	Rs.700/- per worker upto 100 workers and for remaining Rs.500/- per worker.

Where workers are more than 1000	Upto 100 workers Rs.700/- per worker 101 to 1000 Rs.500/- per worker 1001 and more Rs.400/- per worker.

The professional fee/remuneration shall be paid subject to the fund position of the company in liquidation and approval of the Hon'ble High Court.

The Chartered Accountants/firms of Chartered Accountants, who are desirous to be empaneled as above, may send their applications to the Official Liquidator at the above mentioned address. The last date for receipt of applications(s) duly complying with above requirements is **10.03.2025**.
