- 02) EMD in the form of DD for Rs. 1200/- (Rupees Twelve Hundred Only) in favour of BEML Ltd., payable at Bilaspur has to reach the address as mentioned below on or before the closing date and time of the tender:

Technical bid: Following documents should be uploaded in Collaboration Folder on SRM Platform:

- a) Scanned copy of the entire tender document duly signed by the bidder. Any alteration, erasure or over-writing will render the tender invalid. Alteration neatly carried out and duly attested over with the full signature of the bidder however is permitted.

1. **Commercial Bid:** Please quote the price details in 'Item Data' in the system only against the respective items provided therein.
2. Technical Bids of the bidders will be opened first on the Technical Bid Opening Date/Time. Price Bids of the technically accepted bidders only will be opened subsequently on completion of the technical evaluation.
3. The bidder shall accept all the terms and conditions of the tender.

5. BEML Ltd., reserves the right to assess the capacity and capability of the parties for pre-qualification. 14. SCOPE OF WORK: -

1. The firm has to count the physical stock/ Inventory of the HEMM Spares along with our technical team and certify the physical stock report within the stipulated time period.
2. Reconciliation and matching of spares and their quantities with our system records within the stipulated time period.
3. To witness the physical stock verification report prepared by the Regional PSV Committee.
4. All above activities will be carried out at BEML Limited, Sector-C , 1-A, Industrial Area , Tifra, Chakarbhata Post, District-Bilaspur-495220, (C.G)
5. Duration of Work: i) 21 working from the date of commencement of work OR till completion of PSV related work.
6. In case, the contractor / firm after quoting withdraw from the tender or refuse / delay in commencing the work or stop the work abruptly, they will be blacklisted by BEML and contractor's EMD amount shall be forfeited.
7. Number of days for which Audit Services are required – 21 days (Minimum)
8. TCL: Required TCLs for daily work of PSV will be provided by BEML.

TERMS & CONDITIONS:

A. QUALIFICATION CRITERIA: -

The bidders shall submit relevant records in proof of complying with qualification criterion conditions along with the Part – A: Technical Bids.

1. The bidders should be Practicing Cost/ Chartered accountant firm for Physical Stock Verification.
2. Certified chartered accountants from “The institute of chartered accountants of India”.
3. Bidder should have a valid bank account number and shall provide the account details in the technical bid.
4. Bidder should have valid PAN Number; Income Tax will be deducted at source as per the Income Tax rules prevailing.
5. Bidder should have GST registration number.
6. Duly filled Annexure –A & B must be scanned and uploaded on SRM.
7. Experience: The bidder should have executed any Financial Audit Services OR similar Audit of physical stock/ Inventory of the Stores, in support of the experience. The bidders shall submit the list of contracts, indicating the name, value, date of completion of contract, accompanied with copies of work orders issued by respective clients (self attested / certified).

8. Financial Turnover: The bidder should furnish the details of their Annual Turnover and submit the copies of Balance sheet for last 3 years & ITR Returns for last 3 years in support of their Financial Credentials along with Annexure – A & B.
9. **Bidders shall have their office in Chhattisgarh State.**
Party shall submit copies of duly attested Purchase Orders, placed by its esteemed clients (for availing similar kind of services), with the orders necessarily issued on its Office, located within Chhattisgarh State.
10. The L-1 party will be finalized as per the company rules. In-case of two or more parties having same L-1 rate –
 - a. Party having their office in Korba / Bilaspur / Raipur will be preferred.
 - b. Party with more Turnovers during previous year shall be preferred.

B. GENERAL TERMS & CONDITIONS: -

1. Earnest Money Deposit (EMD) as indicated in the NIT (Notice Inviting Tender) is to be submitted along with tender documents Part – A. EMD is payable through Demand Draft favoring BEML Ltd., payable at Bilaspur.
2. EMD given by all unsuccessful Bidders shall be refunded normally within 03 (Three) months. EMD shall not carry any interest.
3. For successful bidder EMD amount shall be refunded, based on Request letter submitted by the firm, once the successful party makes the payment of Security Deposit or PBG.
4. Successful bidder has to submit Security Deposit (SD) of 10% of Contract Value before commencement of the work.

Security Deposit is accepted in the form of DD or BG. The Bank Guarantee should be from any Indian Nationalized / Scheduled Banks only. The Bank Guarantee format should have the approval of BEML Ltd., The security deposit shall not carry any interest.

5. Failure to pay the security deposit shall be treated as failure to discharge the duties under the contract and shall result in cancellation of the contract awarded and the EMD amount will be forfeited. The security deposit shall be refunded within three months after the date of expiry of the contract period subject to the contractor fulfilling all obligations and operations as required under the contract.
6. BEML Ltd., reserves the right to appropriate the whole or any part of the amount of the security deposit without prejudice to other claims against the contractor for losses suffered by BEML due to failures on the part of the contractor or due to termination of contractor becoming disqualified because of liquidation and other reasons. Such losses, damages, charges, expenses or cost, as assumed by BEML Ltd., shall be final and binding the contractor and shall not be called into question.
7. The tender document shall be deemed to form an integral part of the contract to be entered for this work.

8. BEML Ltd., reserves the right to have parallel / similar contract with any number of contractors.
9. Disputes (if any) arising between the company and the supplier in connection with this purchase order or any other matters connected herewith that same referred to a sole arbitrator to be appointed by BEML. The arbitration / proceedings shall be in accordance with provisions of Indian Arbitration and conciliation Act 1996 and Rules framed there under. The place of arbitration shall be at Bilaspur or any other place mutually decided by and between the company and the supplier and all arbitration proceedings shall be conducted in English language. The award of the sole arbitrator shall be final and binding on all the parties.
10. In case of any suit or other legal proceedings arising under or relating to this contract, the courts at Bilaspur shall only have jurisdiction.
11. In the event of contractor failing to provide the services, BEML Ltd., shall be at liberty to make alternative arrangements and the expenditure for such arrangements and for the loss / damage incurred by BEML Ltd., as a result of such non-compliance will be imposed on the successful bidder.
