##### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

##### 2. Purchase Preference (Centre)

Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for percentage of 100% of total value.

6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

## Specification Document

### A. Criteria

In addition to the eligibility criteria mentioned in the bid, following eligibility requirements shall also apply:

1. The firm should be empaneled with C & AG- Proof to be submitted
2. The firm should have office in Delhi- Address Proof to be submitted
3. The firm should have conducted Internal/Statutory audit of at least 1 Autonomous body/ PSU during last 3 years as on 31.03.2025 – Supporting document to be furnished
4. The firm should have conducted internal audit of at least 3 different organizations/entities during last 5 years as on 31.03.2025- Supporting document to be furnished
5. The firm should have average annual turnover of Rs.2 Crores during last three financial years (FY 2022-23 to FY 2024-25)- Copies of audited financial statements to be furnished.
6. The firm should not have any case pending in Institute of Chartered Accountants of India (ICAI), Government of India (GOI), National Company Law Tribunal (NCLT) or any other governing body and the firm should not have been blacklisted by any departments – Undertaking on letter head to be furnished.

The following will be scope of Internal Audit:

- Verification of regular transactions viz. Payment, Receipt, Purchase & Journal vouchers with regard to supporting attached, approval by competent authority, tax deducted at source, Input Tax Credit considered, recoveries to be affected based on inputs from the functional departments, evaluation of the internal control in existence and suggestions for improvement.
- Scrutiny of all transactions relating to capital assets, movement of capital assets from one location to another along with the adequate documentation for returnable and non-returnable cases.
- Scrutiny of Fixed assets register and verification of entries relating to inter unit Transfer of Assets.
- Physical verification of Fixed Assets.

- Random verification of Payroll processing – full/ half pay deduction, joining / exit process, Final settlement of dues, income tax recoveries and proof of savings.
- Random verification of Foreign Travel Settlements.
- Remittance of tax and PF recoveries & e-filing of Income Tax, GST Return and Profession Tax.
- Inter-unit reconciliation.
- Accrual of Income based on invoices raised based on milestone achieved.
- Review of all cases of purchase of components /equipment valued at Rs. 50 lakhs.
- Checking of the valuation of the inventory of components at Delhi and Bangalore Unit.
- Review of Outstanding advances for suppliers & staff, Tot/royalty for more than 1 year – Action taken for recovery.
- Review of Sundry Creditors, EMD, Security Deposit.
- Provision for Gratuity & Leave encashment.
- Verification of vendor payment timelines as per payment terms from receipt of goods/services to payment.
- End to End verification of sample invoices for all Non project related contracts such as Admin contracts, legal contracts etc.

#### General

- Scrutiny of General ledger
- To verify compliance with established policies, effective operation of established systems and other controls.

#### C. Payment terms

- Payment shall be made after submission of Internal audit report.
- Costs of Travel and stay by Partners and Audit Staff by air (economy) between C-DOT Delhi and Bangalore in connection with audit will be arranged by C-DOT.
