- Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Past Project Experience

Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.b. Execution certificate by client with contract value.c. Any other document in support of contract execution like Third Party Inspection release note, etc.

Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. 3. Generic

Option Clause: Excess Settlement. The total invoice amount, including additional charges, shall not exceed the agreed-upon excess settlement percentage for the order.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.

10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

1. For all the necessary details of the Gujarat Horticulture Mission Society, <https://doh.gujarat.gov.in> may be referred to.
2. Henceforth, the successful Chartered Accountant Firm for the accounting work is referred to be as "the firm".
3. Henceforth, Gujarat Horticulture Mission Society, Head Office, Krushi Bhavan, Gandhinagar is referred to be as "HO". There will be one HO.
4. Henceforth, District Offices implementing Head Office scheme or utilizing fund allocated by Head Office is referred to be as "District Office". There will be 33 district offices across the Gujarat State.

5. The scope of work under the assignment shall cover to

BROAD SCOPE OF WORK

- A. The Chartered Accountant firm needs to carry out the statutory audit of Gujarat Horticulture Mission Society for F.Y. 2024-25 in accordance to all the applicable laws/rules/by laws. The said contract which will be extended on the same scope, terms and conditions with 10% increase on accepted fees for subsequent financial years. Such extension will be for maximum Four (4) financial years. The extension will be based on performance of the work.
- B. Audit of the financial statements in accordance with the requirement of Bombay Public Trust Act 1950 and Society Registration Act 1860 along with all the books and all the required vouching etc.
- C. Check of all necessary documents, records and accounts to be kept in respect of the project/scheme/workshop/grant.
- D. Review and assess that the financial information has been prepared using acceptable accounting policies, which have been consistently applied.
- E. Review and assess that the financial information complies with relevant regulations and statutory requirements.
- F. Review and assess that there is adequate disclosure of all material matters relevant to the proper presentation of financial information, subject to statutory requirements, where applicable.
- G. Verification of TDS deduction from salary and other payments.
- H. Issue Audit paras and Verification of compliances of paras raised.
- I. Discuss Draft Audit Report along with Financial Statement at level of Chief executive officer.
- J. The certified copy of the annual Accounts along with the auditor report will have to be presented to the Central Government by Gujarat Horticulture Mission Society. Hence, statutory audit must be completed within the required timeframe so that accounts can be approved by Governing Body of Gujarat Horticulture Mission Society in time. The firm must deploy sufficient manpower to meet this deadline.
- K. The audit report shall be prepared after reviewing the internal audit conducted by the internal auditor of the Society, and based on that, the Utilization Certificate (UTC) shall also be prepared and submitted.
- L. For the relevant financial year, separate audited Utilization Certificates



(in the prescribed format) must be prepared scheme-wise for the funds allocated and the expenditure incurred, and submitted to the respective fund-releasing authorities.

M. In addition to the audited accounts report, the UTC in the prescribed format, as required to be submitted to the Government of India and the Government of Gujarat, must be completed and submitted within the stipulated time limit.

N. The auditors will also be asked to give a presentation on finding in the Audit Reports to the Finance Committee/Board/relevant forums of the Buyer if required.
