Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

2. Purchase preference to Micro and Small Enterprises (MSEs) from the State of Bid Inviting Authority: Purchase preference will be given to MSEs as Micro and Small Enterprises from the State of Bid Inviting Authority. If the bidder wants to avail the Purchase preference, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

3. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Annexure-I

Terms of Reference

1. The office of collectorbotad desires to appoint a C.A. firm for the purpose of carrying out statutory audit of E-seva society,(E-seva and E-dhara fund)botad for the financial year 2022-23 to 2025-26 and submit audit reports.
2. The C.A. firm should be empanelled with C & A G up to whole contract period. And if at any time the empanelment is cancelled, they will inform to chairman of E-seva society and collector botad and contract may be cancelled on that basis.
3. The Auditor should be well conversant with all the guidelines/G.R.s/circular,orders issued from time to time by state Government as well as state level E-seva society.
4. E-sevasocietybotad includes E-seva society(janseva Kendra)and E-dhara fund also that will be treated as a part of unit.
5. The Firm shall place qualified personnel for audit work not below the C.A. with experience of more than one year of statutory audit(audit experience of co.op.society and charitable trust is preferable) and with working knowledge of computer.
6. C.A. firm will carry out audit of E-sevasociety,E-dhara fund and Talukajansevakendra.
7. It will be the responsibility of the auditor to carry out fast and accurate audit as per rules.
8. Any matter requiring urgent attention involving financial or administrative lapse will be separately reported and brought to the notice of authorities concerned.
9. The auditor will make an Audit report yearly and submit to the chairman of E-sevasociety.In case of compliance with ,queriesfrom any authority including AG ,the auditer will co-operate /comply as per requirement.
10. The appointment of auditor will be effective from the date of awarding the contract and the work of audit will be for the financial year of 2022-23 to 2025-26.
11. The auditor shall raise their bills for fees only after completion of the audit and submission of Audit Report.
12. The scope of work shall be as specified in Annexure-I-A& B. Any further clarification on the scope of work can be obtained from collector office,Botad by written correspondence.
13. Auditor shall submit final consolidated audit report as per rules as early as possible, with sufficient reasons for delay, if it occurs.
14. The audit should be carried out independently without any pressure from any office it may be clearly noted that for the purpose of audit the auditors will be appointed directly by the chairman of E-seva society. The audit work should be carried out in an objective, impartial and fair manner.

15. The auditor shall carry out the assignment in accordance with the highest standard of professional and ethical competence and integrity as prescribed by the Code of Conduct and Code of the Institute of Chartered Accountants of India, New Delhi, having due regard to nature and purpose of the assignment, and shall ensure that the personnel assigned to perform the services under this Agreement, will conduct themselves in a manner consistent herewith.

Annexure - I-A

SCOPE OF WORK

1. Guidance will be provided by the firm regarding Books of accounts and records of E-seva society to be prepared and maintained by the Taluka level and district level office.
2. Verify that,
 - (A) Opening Balance adopted tallies with closing balance of last year, Opening Balance & Closing balance of the receipt and payment accounts tallies with the taluka's Cash Book.
 - (B) Funds have been used for the purpose for which they were received.
 - (C) There are two bank account of E-seva society, one of E-seva and second of E-dhara fund. There does not exist any minus balance at any stage during the year, and Interest earned has been added to the society fund.
 - (D) State share for the year has been given every months will have to be certified if required.
 - (E) All receipts/refunds have been correctly accounted for and remitted. Chartered accountant is required to certify/Comment on the final accounts are Maintained as per rules and it shows true and fair view of financial position of society.
3. If Chartered Accountant is the employee of the C.A. Firm then this Employee of a Chartered Accountant firm should have been employed with the firm for a minimum period of one year.

(B) The following records shall be verified by the Auditor while compiling the Audit report.

1. Checking of daily income receipt of E-seva(ATVT) and E-dhara, iora.
2. Checking of all transaction recorded in cash book and bank passbook.
3. Bank reconciliation.
4. Verification of T.D.S. and GST challans.
5. Scrutiny and confirmation of proper classification at the stage of passing bills by the office and pointing out misclassification with adverse effect to be reported proposing guideline.
6. All prevailing rules and guidelines are being followed in the form they are required.
7. Income tax related guidance and compliance will be provided by the firm.

Terms and Conditions

A. General Conditions

A-1 Bid Procedure

1. The whole process of tendering can be cancelled without giving any prior notice or information by the Chairman of E-seva society.
2. The evaluation of the tender will be as per the pre decided terms and condition by E-seva society.
3. The technical bid will be opened first and will be evaluated by a committee of GEM DPC and E-seva society. The financial bid will be opened by this committee only for those auditors who will qualify in technical bid.
4. The documents as per annexure- IV are to be uploaded with the Technical bid for scrutiny of the proposal , without such non attachment of documents tender shall be rejected. The attached documents are to be duly filled up. The Bids bearing incomplete, insufficient, vague details in the documents are liable to be rejected by Chairman E-seva society. No reason shall be given for such rejection.

A-2 Eligibility Conditions

1. For this agreement C.A. firms will be considered eligible which have their head offices registered in Gujarat state duly recorded in the records of the I.C.A.I. and Which has an average annual gross receipt of professional fees/audit and attestation income of at least Rs. 7.00 lakhs per annum over the last three years.The firm must have valid ICAI certificate.
2. The firm must have atleast one C.A.
3. The firm should have completed at least three years since its establishment
4. Documents are required to be attached as per Annexure-IV

B. Commencement, Completion, Modification and Termination of Contract

1. The contract can be terminated from either side, at any time after giving a one month notice to the concerned without mentioning any reason. When the CA request for termination of contract, CA firm will be responsible to pay difference of price of new CA firm.
2. The contract can be terminated from client side at any stage without any notice at the time of occurrence of the events mentioned in 'I'.
3. The contract period in this document is initially for audit of financial year 2022-23 to 2025-26 and after satisfactory performance of CA firm it can be extended for next financial year as per the decision of the Chairman E-seva society.

4. The security deposit @5% of order value will be charged from L-1 bidder which must be submitted within 10 days from awarding the contract and it shall be in a form of Fix Deposit Receipt / Bank Guarantee in the favor of " E SEVA SOCIETY COLECTOR BOTAD" having validity up to 3 months beyond the contract period. The security deposit will be returned only after the completion of the audit work satisfactorily. If L-1 bidder fails in producing security deposit within time limit or denies accepting the work order then EMD will be forfeited and the contract shall be offered to the L-2 bidder at the price of L-1 and in case L-2 denies to do work at L-1 price then differential amount will be charged from L-1 bidder.

C. Payments to the Auditors

1. Fees quoted in bid must be inclusive of all taxes.
2. The payment of fees will be paid only after completion of the Audit work of Financial year 2022-23 to 2025-26.
3. The Auditor should submit an audit Report immediately after completing the audit.

D. Obligations of Auditor

1. The auditor cannot assign this contract, or sub contract it, or any portion of it, to any other C.A / C.A.firm.
2. After completion of audit or in case of termination of Audit, The auditor shall submit No Objection Certificate (NOC) /in prescribed form.

E. Confidentiality

1. The auditor/ their sub-consultants/ partners/ personnel of Audit firm shall not, disclose any proprietary or confidential information relating to the E-seva society, without written authority of Chairman E-seva society.
2. All reports and other documents submitted by auditor shall become and remain the property of the E-seva society's. After expiry of this contract the Auditor shall not use documents and reports of society work under taken by him, without written approval of Chairman of society.

F. Obligation E-seva society's

1. E-seva society will provide relevant guidelines, orders, resolutions GRs etc. bills, vouchers, registers and any other relevant online records for verification of audit.

G. Settlement of Disputes

2. Chairman E-seva society is final authority for settlement of disputes ,under this contract
3. This Contract will have legal jurisdiction within botad district court.

H. Penalties

1. In the event of gross negligence, irregularity, laxity or misconduct on the part of the auditor/auditors personnel, the auditor's contract may be terminated and the C.A. firm may be black listed by Chairman E-seva society, which shall be communicated to all the Government Departments and the Institute of Chartered Accountants for debarring such firm from any

assignment of any Government work. In such a case the C.As of the C.A. firm shall be severally and/or jointly directly responsible.

2. The violation of any of the terms will invoke penalty as deemed fit by chairman E-seva society. It will be the responsibility of the auditor to carry out fast and accurate audit. Failure to do so leading to either undue delay, or laxity or failure to check irregularity in payments will make the C.A. firm liable for being removed from the contract by the Chairman & E-seva society after issuing 15 days notice as well as disciplinary action including C.A. firm may be black listed. The decision of the Chairman will be final
3. In case of termination of this contract the chairman E-seva society can recover following penalty from C.A. firm
 - a. Amount of difference of price values of the new auditor appointed to execute statutory audit.
 - b. Forfeit the audit fees remains unpaid until whole period.
4. The work shall be completed within **6 months** or else penalty will be charged. The amount of penalty will be decided by Chairmen e seva society and collector botad.


