If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.



### **Bid for hiring CA firm for Statutory audit for FY 2025-26 of Mahatma Gandhi Labour Institute**

1. Audit of all expenses and incomes for FY 2025-26 of Mahatma Gandhi Labour Institute.
2. Physical verification of purchased/ created fixed assets during FY 2025-26 and calculation of all assets' depreciation.
3. Prepare annual financial statements and audit report for FY 2025-26.
4. Income tax return filling related works for FY 2025-26 within due date (calculation and filling form 10B and IT return)
5. Assigned work to be completed within 2 month after issuing work order.
6. The bidder shall quote the lump sum professional fees inclusive of all cost, expenses etc. No other additional payments/reimbursement shall be made extra over & above the approved fees, towards transportation/conveyance, other incidental expenses, lodging, boarding, food etc.
7. If MGLI requires any suggestions from the firm regarding Accounting Matters/Income Tax/GST/any direct or in direct tax, the firm must submit their advice about the same.
8. An abnormally low-price raising concerns as to the capability of the bidder to perform the contract shall be liable to be rejected. All decision on reasonability of rates shall be taken solely by MGLI.
9. CA firm must have registered office in Gujarat state.
