Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
4. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

SCOPE OF WORK FOR HIRING TAX CONSULTANT/CA FIRM

The Tax Consultant/CA firm will be responsible for handling GST and Income Tax related matters for NCDC Varanasi branch for the contract period of 01 year. The scope of work includes, but is not limited to, the following:

1. Routine Consultancy & Compliance:

- i. Providing consultancy on GST and Income Tax matters.
- ii. Offering expert opinions on specific queries related to Indirect Taxes.
- iii. Advising on amendments, notifications, and circulars relevant to NCDC Varanasi.
- iv. Providing yearly updates on the impact of changes introduced by the Union Budget relevant to NCDC Varanasi and its employees and clients.

2. Income Tax Compliance:

- i. Filing of quarterly TDS returns (24Q and 26Q).
- ii. Preparation and issuance of Form 16 in respect of salary and non-salary cases (total 14 officials on regular and contractual basis)
- iii. Addressing tax-related queries and notices from the Income Tax Department.

3. Support & Assistance:

- i. Providing assistance in responding to tax-related notices and queries for the current and previous financial years.
- ii. Guiding in systematizing and organizing correspondence with GST and Income Tax authorities.
- iii. Uninterrupted telephonic support for tax-related matters.

TERMS & CONDITIONS

1. The CA firm must be registered with the Institute of Chartered Accountants of India (ICAI) under the Chartered Accountants Act.
2. The firm must have a minimum 03 years of experience in providing similar services.
3. An office of the firm must be located in Varanasi, UP. Documentary evidence to be submitted.
4. The firm will earmark one trained personnel from its office for the IT related work of this office. The assigned personnel will collect the concerned TDS related data (both for salary and other payments, if applicable) from the DDO before the end of every quarter for timely uploading.
5. The firm should have a Permanent Account Number (PAN) and GST Registration certificate for running the business.

6. Performance & Termination Clause:

- i. If the service provided by the vendor is found unsatisfactory or if at any time during the period of contract it is found that the information provided for the contract or any claim is false, NCDC Varanasi shall reserve the right to terminate the contract and remove such vendors from empanelment without giving any notice to the vendor.
- ii. Any delay in filing returns or non-compliance leading to penalties will be the responsibility of the consultant, and the consultant shall bear the cost of such penalties.

7. The firm should provide an Escalation Matrix along with Dedicated/Toll Free Telephone No. for service support.

8. Confidentiality:

- i. The consultant shall maintain strict confidentiality of all financial and tax-related data of NCDC Varanasi.
- ii. No information shall be shared with third parties without prior written approval from NCDC Varanasi.

9. Engagement Period and Payment Terms:

- i. The contract period will be of 01 year from the date of awarding the contract.
- ii. Payment will be made on a quarterly basis on submission of invoices and satisfactory completion of work.

10. Other Conditions:

- i. The consultant shall be responsible for timely compliance with all applicable laws.
- ii. No subcontracting or outsourcing of work is allowed.
- iii. The consultant must be available for meetings at NCDC Varanasi as and when required.
