5. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

SCOPE OF ACCOUNTS WORKS

1. The purpose of Accounting Services is to perform the routine accounting work of BUREAU in Tally Software or any other software as per the general principle of accounting and internal guidelines and to take time-bound appropriate action as per the Government notification from time to time.
2. All transactions shall be recorded in tally software or any other software, as suggested by the Bureau, and the report shall be generated as per requirement. It shall maintain a hard copy of the Ledger book of accounts as per the requirements.
3. Preparation and checking of Receipts, Bank Payment Vouchers, Journal Vouchers, etc. An approximate total of 80 BPVs, JVs, and receipts are prepared and checked per day.
4. Preparation of Bank Reconciliation statement, Income & Expenditure, and Receipts & Payments.
5. Verification of cash book and ledger posting including the posting in the party account to access the amount receivable/payable to any party.
6. Maintenance of Register for Assets, Depreciation & Written-down value of Assets as per the Government notification, etc. and as per General Financial Rules. CA firm shall report the items to be condemned as per Rules and make appropriate entries in books of accounts/Asset Register after their disposal.
7. Preparation of Trial Balance on or before the 7th of every month along with all schedules.
8. Finalization of Annual Closing of Accounts as per HQ guidelines and preparation of consolidated statement.
9. Maintenance of party-wise ledgers in respect of all advances, claims, reimbursement, payments, recovery, and expenses.
10. Preparation of TDS/TCS statement and remittance of the same within the stipulated time and generation of TDS certificate for the respective parties and filing of returns within the stipulated time as per Income Tax Act/Rules/Regulations.
11. Assisting the Bureau in preparing replies to all audit queries w.r.t. CAG Audit, GST Audit, Professional Tax, TDS, Internal Audit, etc.
12. Providing advice and handling of all matters relating to GST, TDS, and all taxes (including all previous financial years) as per Government notification from time to time.
