1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
4. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

1. **Generic**

OPTION CLAUSE 25% : The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 25 percent with the consent of the service provider

2. **Forms of EMD and PBG**

Bidders can also submit the EMD with Fixed Deposit Receipt made out or pledged in the name of A/C

. The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of EMD, the FDR will be released in the favour of the bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Bidder has to upload scanned copy/ proof of the FDR along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date/ Bid Opening date

3. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. 9. Creating bid for items from incorrect categories.

11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

- 1- The applicant firm should be a Partnership firm.
- 2- The applicant firm have to submit Firm registration certificate, Membership certificate/member Card of all the partners, Audited Financial statement of the last three financial year (Balance Sheet and Profit & Loss Account along with schedules for F.Y. 2022-23, 2023-24 and 2024-25), Income Tax Returns of last three FY, copy of PAN card/ GST registration certificate
- 3- The firm should have minimum average annual gross receipts of more than 20 Lakhs in last three financial years i.e. F.Y. 2022-23, 2023-24 and 2024-25.
- 4- The firm should have at least 2 full time Chartered Accountant as partner and at least two chartered accountant should be FCA and at least 1 paid assistants duly registered with ICAI as on 01.01.2026.
- 5- The applicant firm should have Head Office/ Branch office at Raipur (Chhattisgarh), which should be at least 5 year old as of 31/03/2026.
- 6- The firm should have carried out at least 5 similar professional assignment related to any Board / Corporation constituted under the State Law/ any PSU/ Scheme or any local Authority/state government organisation or experience in public sector or municipal audits or Govt Audits (varies by state) in Chhattisgarh for more than 5 years,

- 7- The firm should be peer reviewed CA firm registered with ICAI and empanelment with CAG
- 8- The firm must not have been **debarred, blacklisted, or penalized** by ICAI, C&AG, SEBI, RBI, or any statutory authority.
- 9- The firm must comply with **Guideline No. 1-CA(7)/03/2016** of ICAI:
 - Only firms responding to tenders **with prescribed minimum fees** will be eligible.

10. Scope of work

- Conduct statutory audit of financial statements including **bond proceeds, utilization, and compliance with SEBI regulations.**
- Provide an audit report as per **SEBI (Issue and Listing of Municipal Debt Securities) Regulations, 2015.**
- Signing of Certification as and when required for SEBI reporting

11- FDR or bank draft (issued by nationalized bank) only in favor of Commissioner Municipal Corporation Raipur will be accepted.

12- The firm have to submit EMD in one Envelope clearly marked “ Engagement of firms of Chartered Accountants for Audit of Books of accounts of Raipur Municipal Corporation for the FY 2025-2026.

13- If the date of submission or opening of tender is declared a holiday due to any reason , It will be done on next working day.

14- Conditional tender will not be accepted.

15- Commissioner Municipal Corporation Raipur will have the right to accept or reject any tender.

16- Completion of work - The work should be completed within three month from the date of handing over of the books of accounts.

17- Duration of contract – Initial contract period for the assignment shall be one year. however, based on the performance of work and after approval from competent authority the contract duration may be extended for further period of one year.

18- In case two or more applicants quote the same lowest fees, the preferred applicant shall be selected on the basis of age of the firm (i.e. seniority of the firm) as per records of ICAI, New Delhi.
