1. 2. 6. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Bids are invited to engage C & AG empanelled Chartered Accountant (CA) firms to provide comprehensive accounting, taxation compliance and financial advisory services.

Bids are invited by way of e-tender through Gem Portal under two packet bid system from eligible bidders for hiring the CAG empanelled CA FIRM.

Bidders are advised to read tender document and related corrigendum, if any (uploaded on Gem Portal) and check their eligibility before participating in the bid.

The bidders willing to participate in the bidding process must upload their bids along with the duly self-attested scanned copies of all required documents as applicable in support of their technical and financial bids on the Gem Portal only. Bids received by any other means other than on the Gem Portal shall not be accepted / considered.

Period of Contract: - The period of contract shall be initially for 01 year, extendable upto 02 additional years on satisfactory performance and mutual consent, subject to approval of competent authority. The rates quoted shall remain same during the entire period of contract.

Quarterly payment will be paid to the empanelled CA firm as per the work assigned and performed as defined in scope of work subject to satisfaction of work. All mandatory directions like taxes TDS, as applicable shall be done as per statutory provisions. The empanelled CA firm shall be entirely responsible for all taxes, duties, fees, levies etc. incurred relating to the deliveries of services. The Competent Authority of Rogi Kalyan Samiti CH- 22 reserves the right to deduct any amount from the bill as may be considered reasonable for unsatisfactory services or delay in providing services.

Penalties

If the empanelled CA firm violates the terms and condition of this assignment or indulge in any other cognizable offence or breach, the firm shall be punishable as deemed appropriate by the chairperson of Rogi Kalyan Samiti CH- 22 Chandigarh.

Termination of contract

If the empanelled CA firm is found responsible for any leakage of information, lobbying, etc. then the chairperson of Rogi Kalyan Samiti CH- 22 Chandigarh will have the right to terminate the contract.

Terms and condition for the service of agreement

1. The CA firm must be registered with valid ICAI.
2. In case the CA firm finds any serious financial irregularities and points relating to grave deficiencies, then the same is required to be communicated to competent authority immediately.
3. The CA firm shall in no case use or share the data and information of RKS CH- 22 Chandigarh for the benefit of the CA firm or any person of CA firm.
4. The audit of monthly accounts must be completed by the 10th of every month. The audit of annual accounts must be completed by the 20th April of the financial year.
5. Any losses sustained by CH 22 due to negligence of the CA firms Service in the form of any loss will be recoverable from the CA firm. The decision of the RKS CH 22 in this regard will be final and binding on the firm.
6. The CA firm shall not be allowed to transfer, assign pledge or subcontract its rights and liabilities under this contract to any other agency.
7. Service charge / consultancy charge, or any other charges will not be paid separately for any of the Services.

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. 13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.
